Review of Q2 (April - June 2015) Monitoring data for Tata Landfill, Shotton (Submitted July 2015)

Elevated levels of CO₂ and in BH1(May and June 2015),

Elevated levels of Zinc in groundwater May 2015,

It is considered that the source of ground gas is unlikely to be from the landfill and as such no CCS score has been given.

Likewise the source of zinc contamination is unclear and Tata are monitoring further, no CCS score has been given.

Annual returns submitted to satisfy condition 4.2.1 submitted in various parts May - July 2015
Report contents reviewed and noted, particular reference to failure for CO₂ and Zinc for April 2013 - March 2014. No specific breach of permit due to ground gas/ zinc sources may not be from landfill.

For future reference please note that some parts of condition 4.2.1 are based on calendar year and should be reported by 31st January.
