Natural Resources Wales (NRW) notes that the above report demonstrates very low levels of landfill gas found in leachate wells installed in waste of cell 1. No detectable landfill gas from permanently capped or temporary capped areas of cell 1 was found. NRW are satisfied to keep surface gas monitoring in cell 1 at every 2 years as previously agreed.

No breaches of permit GP3030BE noted.
