Review of landfill monitoring data for Q1 (January 2015 - March 2015) submitted by email 27 April 2015.

Elevated levels of CO₂ for January 2015 in external boreholes:- BH1, BH2, BH8, BH9 and BH10 and again in February 2015:- BH1, BH8 and BH10.

It is not known whether elevated levels of CO₂ are directly related to the landfill or from 'Marsh Gas' from the degradation of the surrounding marshes, as such no scores have been issued for breach of permit.

Tata do not fully understand the cause of the elevated CO₂ levels. NRW agree with Tata's approach to further monitor elevated CO₂ in boreholes, NRW request that further analysis of the elevated gases when detected to ascertain whether these elevated levels are from the landfill or another source.

Elevated levels of Zinc for Q1 found in BH10, the source of the elevated zinc is unknown, as such no scores have been issued for breach of emission limit. Tata to further monitor borehole. NRW request that groundwater flow is established by further monitoring which may give some indication of the contaminant source.
