Review of Q4 (October - December 2015) Monitoring data for Tata Landfill, Shotton.

BH1, BH8 and BH9 showing elevated levels of CO₂ (October, November, December 2015)

BH10 elevated CO₂ (November 2015),

BH2 elevated CO₂ (December 2015),

It is considered by Tata that the elevated levels of CO₂ in the above boreholes are due to the age of the landfill and the location of the boreholes in the marshes.

Gas samples have been taken by Tata and are being further analysed. Further report to be forwarded to NRW imminently. We will assess any permit breaches on receipt of this report.

Elevated levels of Zinc in BH10 (November 2015) - no ccs score due to uncertainty of source of Zinc.

It would be beneficial for Tata and NRW to discuss varying the permitted trigger levels for Zinc. This can be discussed at future compliance audits/inspections at Tata Shotton this year.

Not all the information required under condition 4.2.1 of permit has been submitted by deadline. Please provide this information by 24 February 2016. This breach of permit has been scored one category 4 score.
