Review of landfill monitoring data for Tata Shotton Landfill Q2 (April - June 2017)

Groundwater Monitoring Data

BH10 3 point moving average breached for Zinc, ELV 0.04ppm, Quarter 2 2017 showing 0.07ppm Zinc.

It is not known whether this contamination is from historical landfill and/or reclamation/construction materials. As such no score given for this breach.

Hydrogeological Risk Assessment (HRA) approved by NRW. Suggestions made within report to increase trigger levels for Zinc and other parameters. Tata will need to apply to NRW for a permit variation to alter trigger levels approved within HRA.

Action - Tata to indicate when variation application is likely to be submitted to increase trigger levels.

Gas Monitoring Wells

In waste gas monitoring wells L6 - noted methane concentration 4.8% and carbon dioxide concentration of 9.8%.

Tata are in the process of drilling new gas monitoring wells that will re-characterise the gas regime on site. Tata to inform NRW upon completion of installation of wells.
