Review of monitoring data for Q3 (July - September 2016)

Leachate well L6 continues to show elevated levels of Carbon Dioxide, Methane and depleted Oxygen. Maximum levels of CO2 15.3% and 8.2% Methane in August 2016.

External monitoring wells show elevated levels of CO2 above 1.5% ELV monitored in BH2, BH9 and BH10 with a maximum of 3% displayed in BH10 August 2016.

As historically discussed between NRW and Tata it is considered that the elevated levels of CO2 and Methane is unknown but thought to be from the surrounding marshland rather the landfill. The situation should be carefully monitored to ensure that the landfill gas levels detected in leachate well L6 are not detected in the external monitoring wells.

Three point moving average for Zinc 0.06ppm against a trigger level ELV of 0.04ppm. It is considered that the breach may be from land reclamation material used in construction/reclamation rather than the landfill itself. Due to recent discussions between NRW and site following submission of HRA report, Tata are to apply to vary to increase trigger levels, as such no CCS score given.
