Review of Shotton landfill monitoring data for Q3 (July - September 2017).

Groundwater Monitoring Data

Emissions of zinc 0.07ppm from BH10 against an ELV (three point moving average) 0.04ppm.

Not known whether emissions are from historic landfill and/or reclamation/construction materials. No score has been given for this breach.

Approved revised HRA, suggestions to increase trigger levels. Tata will need to submit permit variation to increase trigger levels. Following discussion with Tata, this will be done upon completion of revised gas monitoring.

Gas Monitoring

External wells data showing elevated levels of CO₂ against ELV 1.5%

BH1 Max 3.6%

BH2 Max 2.0%

BH8 Max 1.9%

It is not known whether source is anthropogenic or from surrounding marshland, no score given for breach.

In waste leachate wells showing elevated CO₂:-

L6 Max 17.4%

L1 Max 6.6%

Tata have installed new gas monitoring wells within waste that will allow gas regime recharacterisation. New data will be included within Q4 monitoring returns.
