The following notice gives notice of the variation of an environmental permit.

This variation allows the addition of a non-hazardous waste type for disposal at the landfill. Waste type 19 13 06 – sludges from groundwater remediation is now included for disposal. This variation also changes the Operators name to Tata Steel UK Limited following their acquisition of Corus UK Limited in 2007. The company number has not changed.
