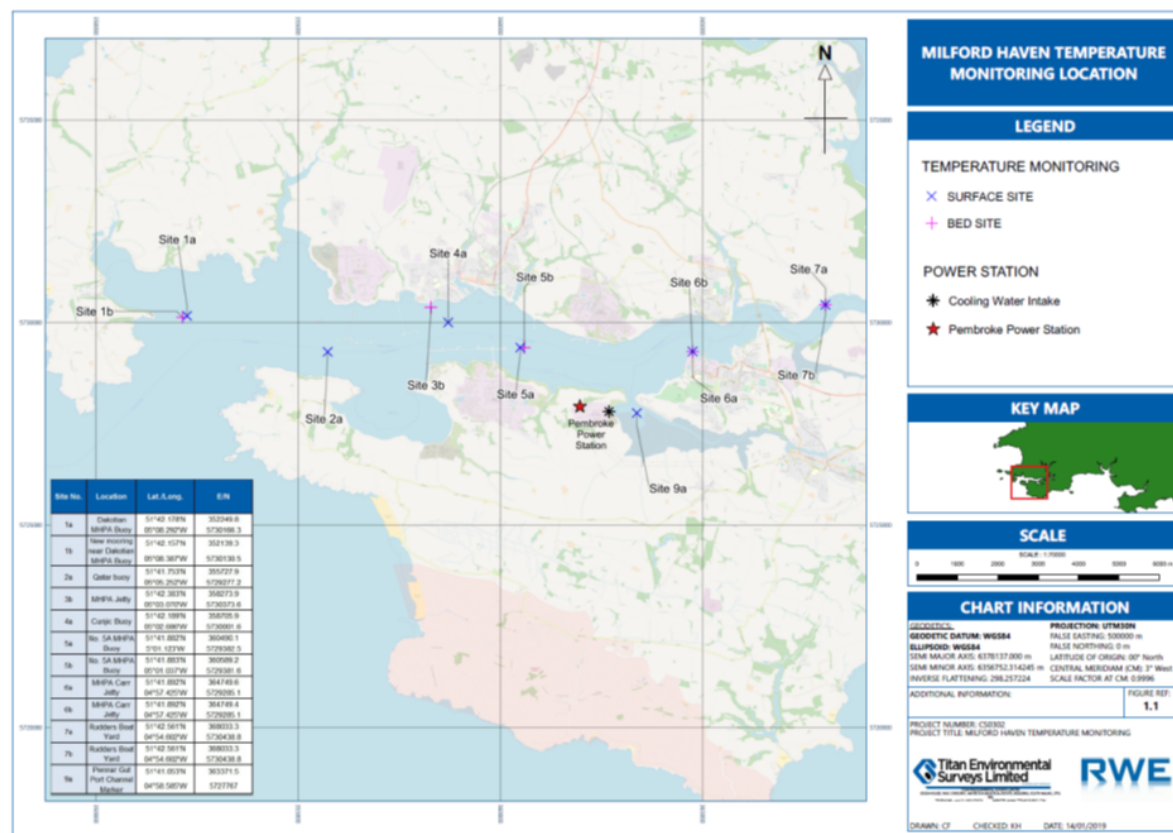

4. Details of our assessment

Introduction

RWE's Water Policy Manager for Pembroke Power Station submitted a written request to NRW advising that the operator was seeking an agreement with NRW to cease the temperature monitoring that it has carried

out in the Milford Haven Estuary since 2011. In 2010 before the power station started operations a number of moorings were deployed along the Milford haven Estuary to collect temperature data. The location of the moorings fitted with temperature instruments and the power station are shown below:



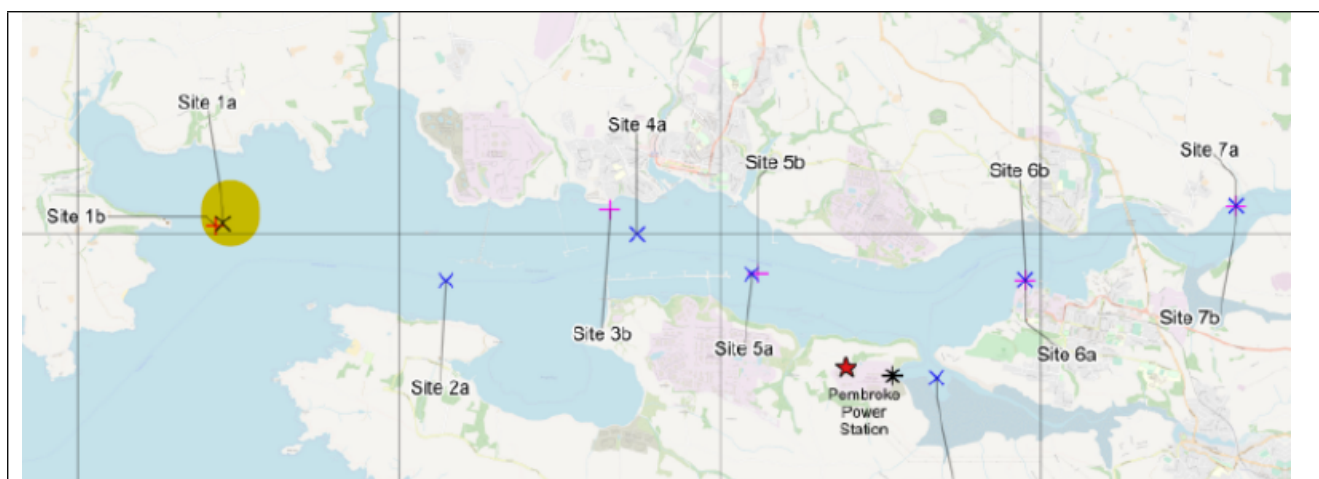
This request does not relate to any of the biological or other physical (water quality and sediments) monitoring that the operator has agreed to undertake until 2025.

Supporting technical information

A surveying company has been contracted to provide statistical summary documents for each year of data that has been recorded from the instruments. That data is analysed further by RWE with the operator also making use of its hydrodynamic model to assist in interpreting the observed temperatures. The interpretative reviews of both data sets have not identified any changes that would warrant any further analysis or investigations with conclusions consistent between all reviews. The primary findings from RWE conclude that meteorology is a key driver of the seasonal variation in measured water temperature and the spring-neap tidal cycle is a driver of the medium-term variation in measured water temperature.

NRW response

RWE's written request and justification to stop temperature monitoring in the Milford Haven Estuary was consulted internally with NRW marine specialists with a meeting held to discuss the request with RWE. While it was acknowledged by NRW that the model does not require further in situ data as it has been calibrated with 10 years of data NRW raised concerns that should the operation of the power station change for instance a new discharge pathway then further validation data will be required. To ensure that any climate change scenarios are captured NRW has requested that one thermal monitoring site is maintained with site 1a highlighted below identified as the most appropriate site to remain.



NRW has also agreed with the operator that if any future concerns arise and additional monitoring be necessary then the network will be reinstated. The 9 monitoring sites are due to be removed in October 2022, NRW is to be notified by the operator when that action is completed.
