Harp International LTD

In **CAR_NRW0039928** Harp International Ltd were tasked with the following action:

Action 1 Harp 19th of May 2022; Update NRW with the conclusions to the fate of the bund / oil tank once Harp have held internal discussions and made a formal decision.

NRW received the following response on the 6th of June 2022,

“The oil tank is empty and will no longer be used. No liquids will be stored within the bund going forward unless they are on a bunded pallet. As mentioned previously, any oil from the reclaim plant will be transferred to 205 litre drums and stored on a bunded pallet until they are collected for recycling.”

Subsequently the oil tank was removed from site on the 10th of June 2022, and the site intends to remove the bund in due course.

All outstanding actions are now considered complete.
