1. Fugitive Emissions Survey

A walkover methane fugitive emissions survey was completed by Natural Resources Wales on cells 1, 2, 3 & 4 using a Gazomat methane detector. The capped surface and discrete features including landfill gas wells, connecting pipework and leachate collection chambers were surveyed. However, not all infrastructure was surveyed.

No physical defects were found with any gas wells or connecting pipework. Pipework falls were generally good but some becoming more challenging on cell 4 due to settlement of the waste mass although these falls are still acceptable. Gwynedd council have taken some simple and effective measures to ensure falls are maintained but this issue should remain under review as the waste mass settles further.

No odours were noted whatsoever during the survey and methane emissions did not rise above background at any features. The findings of this inspection are the same as the previous inspection in October 2014 indicating that landfill gas is being well managed.

Please note that no gas quality data was collected so this falls outside the scope of the inspection.

2. Landfill Gas Infrastructure Inspections

Records of weekly infrastructure inspections completed by the site manager were inspected - where any faults are observed they are passed onto the site technician for remedial action. No problems were observed on the landfill indicating that the system is working well.

A landfill gas infrastructure audit was completed by Gwynedd Council 06/02/15 and actions addressed/ The audit is completed annually in addition to the weekly walkover inspection and landfill gas balancing.

As discussed we would recommend that a perimeter walk of the cells is also completed on a weekly basis to check the integrity of the cap and any potential leachate outbreaks.

3. Landfill Cap

The capped surface appeared to be in good condition with no evidence of instability observed. As above, the waste continues to settle, particularly in cell 4 which was most recently completed. No issues noticed.

The CQA validation report for capping works on cell 4 (2014) has been approved by Natural Resources Wales. Approval has been issued by means of a separate letter.

4. Monitoring Data

As discussed routine monitoring data for the period July -September 2014 was received late and the report for October - December 2014 has not yet been received (due January 2015). This is in breach of permit condition 4.2.2 and attracts a CCS score of 4. **Please submit outstanding monitoring data without delay / inform NRW as to when data will be submitted.**

Please note that your annual environmental monitoring review and associated reports should be submitted by 31/03/15.
