Comments

This Compliance Assessment Report follows a site inspection on 25/11/13 and a review of the CQA validation report provided for cell 3 capping works.

The inspection covered a walkover of cells 1, 2, 3 & 4a.

1. Site Walkover Findings

In summary no significant issues were noted with the gas extraction system;

- Pipework falls were generally good on cells 1,2 and 3 with little potential for condensate blockages.
- No fugitive emissions (LFG odour) noted from any gas wells. All leachate collection wells on cells 1 - 3 were well sealed with gas control.
- On cell 4a some temporary gas well connecting pipework may be prone to condensate traps due to the surface topography. These lines are being dewatered manually on a daily basis as required. Falls will need to be improved upon capping works.
- Some fugitive emissions were noted along the sidewall edge of cell 4a / b - gas extraction on cell 4b is required as soon as practicable.

No issues noted with existing capping works.

A suitable margin has been left between the waste mass and cell perimeter bund for cells 4a and 4b to minimise risk of leachate runoff to unmade ground.

Litter - no litter was noted off site and the site was generally litter free - litter pickers were working on site during the inspection.

2. Cell 3 Capping CQA Validation Report

Thankyou for providing the CQA Validation Report for the Capping Works to Cell 3 Area 3. This is the latest in a series of Validation Reports and follows the format of previous reports.

The works described in the report have been installed in accordance with the CQA Plan. The tests and samples have been taken at the required frequency and the results of the tests demonstrate compliance with the requirements of the approved Plan. The drawings included with the report show the extent of the works, as well as the location and number of all Geosynthetic panels and repairs.

I am satisfied that the Validation report contains the details required and demonstrates that the CQA Plan has been followed and is therefore approved.
