A walkover methane fugitive emissions survey was completed by Natural Resources Wales on cells 1, 2, 3 & 4 using a Gazomat methane detector. The landfill is now 100% capped with landfill gas management and leachate collection infrastructure installed. The capped surface and discrete features including landfill gas wells, connecting pipe work, manifolds and leachate collection chambers were surveyed. However, not all infrastructure was surveyed.

No odours were noted whatsoever during the survey and methane emissions did not rise above background at any features other than LCP3 where 1.5% was measured from a small crack in the restoration soils around the well base (no odour noted). The well is fitted with gas control.

Advice & Guidance - Check well ground seal and re-balance as appropriate.

The cap of cell 4 (completed early 2014) appeared to be in good condition and no obvious stability issues were noted. CQA report for capping works due for submission.
