This Compliance Assessment Report follows a review of routine monitoring data for the period April - June 2013. It reviews data for Area 3 only.

### Leachate Heads

All heads measured as <1.5m - compliant with permit.

### Leachate Quality

Leachate quality collected from individual cells as per permit requirements. No issues noted with sample data.

### Perimeter Gas Monitoring

Monitoring took place at designated monitoring wells - no trigger limits exceeded.

### Groundwater Quality

Hazardous substances screen completed.

Page 13 of the report states that following variation EPR/PP3294FJ/V008 trigger levels as set in permit QP3134LY have been revised. This is not strictly correct as permit variation EPR/PP3294FJ/V008 is a variation of the dilute and disperse landfill permit (Area 2) and does not change the trigger levels in the PPC permit QP3134LY (Area 3). Following the collection of naphthalene data a variation will be required to update the PPC permit and incorporate the new trigger levels

However, given that the trigger levels have been agreed in principle I agree to you assessing monitoring data for both permits against the trigger limits set out in permit EPR/PP3294FJ/V008.

Revised trigger limits were exceeded in BH20A and BH19B during the period. As previously stated it is realistic to assume that these trigger breaches are attributable to the plume migration from Area 2.

### Surface Water Quality
