This report covers a review of the Annual Environmental Report for Ffridd Rasus (Area 2) in 2012. The report reviews environmental monitoring data that has been submitted to Natural Resources Wales throughout 2012 and the existing risk assessments for various aspects of site operations.

Surface Water Quality - page 14 of the report highlights elevated COD in samples collected from SW1, SW2 and SW3 (SW3 in particular) during 2012. No comment has been provided as to the possible cause(s) and I would welcome further interpretation as to whether this is linked to site operations or other sources.

Annual Flare Emissions Monitoring completed 6th February 2013 - emissions fully compliant with permitted ELVs. No issues noted.

Annual landfill gas trace gas analysis completed - no issues noted with trace gases.

Hydro geological Risk Assessment (HRA) - the report highlights an increase in leachate strength for a number of parameters and recommends a review of the site HRA. Following agreement to naphthalene trigger levels and the ongoing collection of groundwater quality data from Area 2 (wells installed 2012) we will consider the need to review the HRA for the site - issue to remain under review.

Please ensure annual reviews are provided on time. A CCS score for late reporting was applied in a previous Compliance Assessment Report.
