This Compliance Assessment Report follows a site inspection to allow for the potential closure of the landfill (Area 3) following receipt of a closure application. The application is being determined and a decision of closure by NRW's National Permitting Team is due shortly. The objective of the inspection was to ensure that there is no permit non-compliance, particularly with regard to site engineering and landfill gas emissions.

A walkover methane fugitive emissions survey was completed by NRW (with the site Manager present) on cells 1, 2, 3 & 4 using a Gazomat methane detector. The capped surface and discrete features including landfill gas wells, connecting pipe work and leachate collection chambers were surveyed. The flare was operational but the compound was not accessed / inspected further.

The findings were in line with recent inspections that have not identified any issues of concern - no physical defects were found with any gas wells or connecting pipe work. Pipe work falls (where inspected) were adequate and the operator reports that minor adjustments are being carried out as necessary for allow for the waste mass settlement.

No odours were noted whatsoever during the survey and methane emissions did not rise above backgrounded at any features.

The capped surface appeared to be in good condition with no evidence of instability observed. All capping has been completed in accordance with CQA requirements.
