A walkover methane fugitive emissions survey was completed by Natural Resources Wales on cells 1, 2, 3 & 4 using a Gazomat methane detector. The capped surface and discrete features including landfill gas wells, connecting pipe work and leachate collection chambers were surveyed. However, not all infrastructure was surveyed.

No physical defects were found with any gas wells or connecting pipe work. Pipe work falls (where inspected) were adequate and the operator reports that minor adjustments are being carried out as necessary for allow for the waste mass settlement.

No odours were noted whatsoever during the survey and methane emissions did not rise above background at any features or during the walkover of the site.

The site manager reports that weekly infrastructure inspections continue to be carried out (records inspected previously by NRW).

The capped surface appeared to be in good condition with no evidence of instability observed.
