4. Details of our assessment

The purpose of this Compliance Assessment Report (CAR) is to record breaches of the environmental permit reference EPR/VP3935AT arising from the exceedance of permitted emission limits during Q1 2022.

For assessment activities taking place from the start of 2022 emission limit breaches from **groundwater boreholes** and **perimeter landfill gas wells** will be consolidated when:

- a) exceedances have occurred at different monitoring points (e.g. different boreholes) BUT
- b) the breaches occurred within the same monitoring period (i.e. Q1, Q2, Q3 or Q4) AND
- c) for the same emission parameter with a limit (e.g. ammoniacal nitrogen). If another parameter (e.g. phenol) breaches its limit a separate score would be applied.

NRW is currently reviewing and updating its guidance on compliance assessment. This interpretation and approach will be included in the Annex for landfills.

Leachate Levels

Condition 2.8.1 and 3.1.2 of the environmental permit states:

2.8.1 The limits for the level of leachate listed in schedule 3 table S3.1 shall not be exceeded.

3.1.2 The limits given in schedule 3 shall not be exceeded.
