The purpose of the site visit was to discuss a Transboundary Movement of waste from Ireland, review implication of changes to COMAH legislation, and review some waste documentation. A site walkover was also undertaken.

Transboundary Movement of Waste

Natural Resources Wales have been assessing documentation to allow the movement of waste from a site in Ireland to this Permitted site. Following receipt of further information it has now been agreed that the EWC code of 16 05 04* is appropriate. Although, the site is Permitted to take this waste type for reclamation and re-use by distillation, this is limited to HCFCs, HFCs, and HCs. Despite consisting mostly of HFCs, the proposed waste type also contains Ethanol and pharmaceutical ingredients.

The Operator is to provide NRW with a proposal for such a reclamation process prior to acceptance of this waste.

COMAH

The Operator is aware of some of the changes to COMAH legislation. He is to review the new thresholds for liquefied flammable gas of 50 tonnes and flammable gas of 10 tonnes to justify whether the site would fall under Lower Tier regulation. Such a justification should be submitted to NRW by 31st July 2015.

NRW will advise on the implications of coming into COMAH.

Waste Transfer Documentation

The Operator is to review, hazard coding for waste, following recent changes and ensure all documentation is correct. This is likely to be HP3.

Site Inspection

The site was found to be clean and tidy with no amenity issues. Waste bays are labelled and a board is kept up to date with current tonnage stored and location. A number of incoming containers were noted to be incorrectly labelled as 'Non-Flammable'. The Operator agreed to address this straight away.
