This inspection was a routine site inspection carried out by Tony Bruten.

The inspection was based on BATS compliance returns submitted in 2021 and general visual site inspection.

All record keeping was present and accurate.

A walk over site inspection was carried out specifically checking drainage both clean and foul water.

there were no issues and where the clean water discharged into the watercourse there was no evidence of any pollution.

All yard concrete was in good condition with only minimal cracks.

There was no dust, odour or noise at the time of the inspection.

The site was in good general repair and no non conformances were identified.
