Review of annual returns to satisfy reporting conditions of permit SP3430RL

Energy and Water Usage and Waste Disposal

Review of energy and waste disposal data for 2015 – no significant increases noted over 2014 data.

Water Usage Figures Annual Report – it is noted that site is currently running at a high rate of water use per bird compared to Best Available Technique (BAT) Benchmarks, site have set a target of 18 litres per bird for 2016, a reduction of approximately 25%. Although it is noted that water usage has increased over 2014 data due to decrease in production.

Emissions To Sewer

Emissions to sewer – Emission point S1 from Effluent Treatment Plant (ETP), no mercury detected in discharge to sewer. Effluent is running with discharge consent levels set by Welsh Water.

Annual reports not submitted by deadline (31st January 2016), permit breach, scored one CCS category 4 score. Procedures should be reviewed on site to ensure that annual return/monitoring are forwarded to NRW by the correct deadline. Site to update reporting procedure and forward to NRW by 26 March 2016.

WU1 –submitted for Q1 (Jan 2015 – March 2015), Q2 (April – June 2015), Q3 (July – September 2015) – received in December 2015. (see above for comments regarding water useage)

Accident Management Plan (AMP) and Waste Management submitted 15 January 2016, AMP – no issues noted with submitted documents.
