4. Details of our assessment

Present: -

Weather: Overcast for the duration of the inspection.

This was a routine inspection as part of Natural Resources Wales' Closed Landfill Project

The aim of the inspection was to determine compliance with the sites' environmental permit and supporting documents. Findings of the inspection are set out below.

Groundwater and landfill gas monitoring points: None present at site.

Leachate monitoring points: None present at site.

Landfill gas extraction points: None present at site.

Landfill surface: Unclear if any formal cap has been placed on top of the waste mass. Signs of pooling rainwater and larger pond to corner of site. Established vegetation – Mainly brambles. Site levels are varying with large mounds, higher than surrounding surface dotted across the site. No evidence of slippages or cracks/movement of the landfill mass were encountered. No evidence of leachate outbreaks, landfill gas odours or any unusual vegetation die back were encountered. Evidence of dumping of rubble and off-road vehicle use on the landfill surface.

Water receptors: A stream flowing to the side of the landfill was observed. The water was running clear and exhibited no odour.

Gas utilisation plant and flare: None present at site.

Security: Site accessible via a field gate.

Source term: Local resident reported that liquid abattoir waste was believed to have been tipped into sections of the site, during its operational phase.

Proposed, future use: Local resident said that the site had been earmarked for local development.
