4. Details of our assessment

On 16 May 2022 08:03 Knauf Insulation Limited notified Natural Resources Wales that the

by-pass stack would be operated for approximately 48 hours on Tuesday 24th May at 14:00 until 14:00 Thursday 26th May so to enable planned, preventative maintenance of the electrostatic precipitator.

During this period of by-pass stack operation, the process feedstock pull rate and furnace output was reduced so to limit emissions to air.

Knauf Insulation Limited explained that notifying Natural Resources Wales of the planned operation of the by-pass stack was delayed because of an unexpected staff absence.

In response to the notification timescale, Natural Resources Wales make the following points:

Condition 4.3.5 of the permit states where the operator proposes to make a change in the nature or functioning, or an extension of the activities, which may have consequences for the environment and the change is not otherwise the subject of an application for approval under the Regulations or this permit: (a) Natural Resources Wales shall be notified at least 14 days before making the change; and (b) the notification shall contain a description of the proposed change in operation.

As the notification was received in less than 14 days, condition 4.3.5 has been breached.

However, as this breach was due to extenuating circumstances (unexpected staff absence) and in itself will not have contributed to any additional environmental impact Natural Resources Wales will not score against this non-compliance and instead require the following action:

Action Knauf Insulation Limited: Make provisions to ensure there is sufficient cover for key members of staff during periods of unexpected absence, so to ensure ongoing compliance with permit conditions.
