The site appeared in good order with waste segregated and contained within appropriate bays/containers.

The site benefits from CCTV cameras, lockable gates and high fencing.

Mr Matthews informed the officer that at the moment the permitted activities are kept to a minimum.

It would correlate with the amount of waste kept on site.

WAMITAB certificate was discussed. Mr Matthews told the officer that he had recently taken the exam and received his certificate.
