Prior to attending site at 10.00 10 March 2016 a tour of neighbouring estates was undertaken IO to assess whether there were any odours that could be attributed to Hafod Landfill (not raining, light breeze). Areas visited include: gas compound on the corner of New Hall Road, New Hall Road, Daniels Drive, Vauxhall Industrial Estate, Heol estate, Y Gesail, Bangor Road to Snowdon Drive and Bangor Road to gas compound / site entrance. No off site odours attributable to site activities were identified (though a mild wood drying odour was noted in the vicinity of Vauxhall Industrial Estate).

A meeting was held on site between Natural Resources Wales (NRW) IO/KR and Cory personnel IC/DW to discuss the Hydrogeological Risk Assessment (HRA) with specific reference to CAR HRA submission response PP3139GB/0256311 issued 29 January 2016. The outcome of the meeting was for Cory to update the HRA submission with further information / clarification and to resubmit once the content had been agreed with NRW.

Following the meeting NRW inspected the site to further inform the HRA with particular reference to the position and operation of groundwater boreholes, abstraction, lagoon and discharge to surface water. An assessment of odour on site was that of fresh waste on the tipping areas. The presence of the pest controller and hawk and the further cover and new wells in the south east of Cell 3 were also noted.
