Compliance Q4 (October – December) 2015 – Monitoring data review

a). CCS3 – Engineering to prevent emissions, leachate levels C2.9.1, S4.1

Leachate exceedance (reference HAF 102v10, v11 & v12).

Extraction monthly figures of 1390, 2680 and 2828 m<sup>3</sup>.

Cell1 - Re-drilled leachate well LMP1a collapsed and was re-drilled in November as MP1b and a pump installed to draw down leachate and on 17 November a level of 3.86 m (versus 2m limit) was recorded. Perched leachate was encountered on drilling and on 24 November the level had increased to 24.44 m (and 24.78 m 21 December). Due to high temperatures > 50 C the extraction pipework kept bursting. This has been replaced with a more resistant pipe and the leachate level should be much improved in January.

Cell 2 – Readings of 3.21, 12.45 and 6.29 m and pumps plagued with foam and sludge blockages. The pneumatic pump is to be replaced with electric pump in January.

Cell 3 – Compliant though an obstruction has made measurement difficult.

b). CCS3 – Emissions to air C3.3.5, S4.5

Various perimeter gas well exceedance (reference HAF 121, 125 & 126) with methane ranging 0 – 25%

versus 1% limit and / or carbon dioxide levels ranging 1 – 15% versus 1.5% limit (not under positive pressure). Subject to actions arising from NRW gas audit 20 & 21 August (reference PP3139GB / 0249675) with 18 new inboard wells being drilled in Q1 2016.

c). CCS3 Suspended – Emissions to land and groundwater C3.2.3, S4.4

Exceedance of groundwater borehole HA 12B (B) chloride levels at 1200, 1000 and 1300 mg/l versus 450 mg/l trigger level (reference HAF 122, 124 & 127). Borehole + 300 m away on the slip road of A483 has historically high chloride levels (ammonia compliant at 0.74, <0.015 & 0.02 mg/l versus 2 mg/l limit). NRW has agreed to proposals to decommission HA 12B (B) in favour of a new well in the north west corner inboard of site drilled 11 November reference HA 12C. This well will have the same monitoring requirements and is discussed in the on-going Hydrogeological Risk Assessment (HRA).

Groundwater borehole HA 9B (M) October ammonia exceedance of 11 versus 4 mg/l returning to <0.015 in November (no associated chloride exceedance, considered to be an anomaly (also included in the HRA determination)).

d). CCS4 Emissions to surface water C3.1.2, S4.3

SW2 surface water discharge marginal exceedance of alkalinity of 350 versus 323 mg/l.
