CCS 3 - Off-site odour, 22 August 2017

Condition 3.4 Odour, 3.4.1 - Emissions from the activities shall be free from odour at levels likely to cause annoyance outside the site, as perceived by an authorised officer of the Agency (NRW), unless the operator has used appropriate measures to prevent or where that is not practicable to minimise the odour.

NRW received two odour complaints regarding Hafod Landfill on the 22nd of August 2017, at 14:12 and 15:13, both in Johnstown. NRW subsequently visited Johnstown to investigate, when two officers identified a strong waste odour off-site on Heol Orsaf, Bangor Road, Tanyclawdd, Plas Tirion, Gwalia, Glasfryn and Plas Tirion between 16:10 and 16:23.

Natural Resources Wales then visited the site and spoke to Dave Leonard of Cory Environmental. Mr Leonard stated that the site had been accepting a large volume of waste due to the shut down of an incinerator in Merseyside. He also stated that the last load of the day had just been accepted, and that the waste would then be covered.

We received a complaint response report from Cory Environmental on the 23rd of August. The report referred to an odour inspection carried out after the first complaint was received when intermittent fresh waste odour was detected downwind on the Bangor Rd / railway bridge boundary, however, no odours were identified offsite. In subsequent discussions with Cory Environmental, it was determined that the waste material being accepted from Merseyside was to end on the 25th of August.

This is the second time NRW has substantiated odour complaints related to the acceptance of waste from the incinerator in Merseyside, the last occurrence being in May 2017. It appears that this waste stream is particularly odorous and therefore Cory Environmental should ensure that adequate provisions are in place to prevent or where that is not practicable to minimise the odour.

Action 1: Cory to provide NRW with details of specific provisions regarding odour emissions for the future acceptance of waste from the incinerator in Merseyside, by 30th September 2017.
