Offsite odour, 09/04/2018

Condition 3.4.1 states that emissions from the activities shall be free from odours at levels likely to cause annoyance outside the site, as perceived by an authorised officer of the Agency (Natural Resources Wales), unless the operator has used appropriate measures to prevent or where that is not practicable to minimise the odour.

Following the receipt of an odour complaint received by NRW at 11:48 on 09/04/2018 (WIRS reference 1801908), Regulatory Officer Jim McClymont conducted an odour monitoring survey around the site and neighbouring estates.

A waste odour, at levels likely to cause annoyance, was detected by Jim McClymont at Y Gesail at 14:28.

This breach has been scored a Category CCS3 breach of permit.

Jim McClymont then went on to site and spoke to the weighbridge operator regarding the waste odour detected offsite, the permit condition breach and the likely compliance score.

From the weighbridge it was noted that the operational tipping area appeared to be now approaching the top of the flank. Careful consideration will have to be given when tipping at this elevation, particularly when the wind direction is towards properties beyond the NW boundary.

The operational tipping area will be further inspected during the upcoming site audit, on 01/05/2018.
