Cell 4 Upper Western Sidewall CQA Plan

We have examined the CQA Plan for Cell 4 Upper Western Sidewall at Hafod Landfill Site. The Plan is based upon a series of previous similar CQA Plans. This Plan has been revised to take account of design changes that were agreed during the Eastern Sidewall engineering in 2016.

There was one aspect of the Plan that was different from previous plans, the groundwater drainage sump. The text and drawings attached to the document did not show how the risers socket into the sump. The two drawings showed the risers and one showed the irregular shaped sump but the detail of how this arrangement works was not clear.

Cory were asked to provide a drawing of the sump/riser arrangement so that the detail could be agreed. Drawing, HAF174 Proposed Sidewall Groundwater Extraction, was received on the 8th of June 2017.

Review of this drawing revealed no shortcomings, and accordingly the Plan is accepted in its current form.
