Any more accurate information on the matters for notification under Part A.	<p>The levels in LC1 have fluctuated between 14.76m and 6.76m during August. The transducer readings have been compliant throughout, but only at the depth the pump can be lowered to.</p> <p>A camera survey was undertaken on the 27th August and it was found that the two monitoring chambers LC1 and LC2 have damaged pipework which restricts the opening and is preventing the pumps going down to the base of the chamber. A separate email will be sent to NRW detailing what remedial measures are proposed.</p> <p>LC2 has been consistently below compliance levels throughout this reporting period.</p> <p>The levels in LC3 were 2.84m on the 6th August. The pump was checked and found to be working albeit at a slow flow rate. However, we have since replaced the pump and this has now brought the levels back under compliance.</p> <p>During August 1878 m3 of leachate was removed from site for treatment. 303 m3 of this was taken to Brookhill Landfill as part of a treatment trial.</p>
