Any more accurate information on the matters for notification under Part A.	Borehole 12B(B) is 300+ metres away from the site, on the side of the slip road to the A483 dual carriageway. It is highly unlikely that an emission is occurring, as ammoniacal nitrogen is compliant.
Measures taken, or intended to be taken, to prevent a recurrence of the incident	No intended action is deemed necessary at this time. We will review the next few sets of results. Until any increasing trends are confirmed across a range of leachate-indicating substances, these results should be viewed as representative of background concentrations and/or weather events. The permit limit has been raised to 450 mg/l for borehole 12 due to historical results; however as background concentrations continue to vary this may need to be reviewed again in future.
