### Compliance Q2 2014

- CCS3 - Condition 3.3.5 and S4.5 Various perimeter gas well exceedences (landfill methane migration, mines gas and carbon dioxide with and without methane) for April - June 2014 (submission references HAF088, 090 and 091) with methane ranging 0 - 44% versus 1% and/or carbon dioxide ranging 0.8 - 31% versus 1.5%.

Exceedences should reduce as a result of infrastructure improvements arising from Natural Resources Wales gas audit July 2014.

- CCS3 - Condition 2.9.1 and S4.1 Leachate level exceedences in Cells 1-3 for April - June 2014 (submission references HAF084v4, v5 and v6) thought to be perched leachate (removed 1668, 1868 and 1544m3). Problems persist with pump blockages and obstructions making it difficult to get accurate leachate head readings.

Cory to submit a program of works to Natural Resources Wales to resolve issues of high leachate head readings and blockages by Friday 12 September 2014, with the works to be completed by 31 October 2014.

- CCS3 - Condition 3.2.3 and S4.4 Groundwater monitoring borehole HA12B(B) chloride levels for April - June 2014 (submission references HAF082v4, v5 and v6) at 1000, 1200 and 1300 versus 450 mg/l. Borehole 300+m from the site to the east on the slip road of the A483, has had historically high chloride levels (ammonia in compliance 15 results highest 0.75 versus 2 mg/l).
- CCS3 - Condition 3.1.2 and S4.3 Surface water exceedences at SW2 8 April 2014 (submission reference HAF089) for routine chloride 100 versus 67 mg/l and sulphate 240 versus 224 mg/l. Thought to be the result of a chalky seam in the clay washed out by the rain (ditches to be excavated to bypass).
