Compliance Q3 (July - September) 2015 - Monitoring data review

a). CCS3 Suspended - Engineering to prevent emissions, leachate levels C2.9.1, S4.1

Re-drilled leachate well Cell 1 LMP1a had collapsed and was re-drilled again in November this time in steel casing (no results in Q3 due to access problems to replace). Cell 2 re-drilled leachate well LMP2a was not compliant on 27 August (2.6 m versus 2.0 m limit) but compliant in July and September. Cell 3 leachate well has been compliant. Refer to notifications HAF 102 V7, 8 & 9. Leachate monthly figures of 1343, 1502 and 2128 m3.

b). CCS3 Suspended - Emissions to air C3.3.5, S4.5


Various perimeter well exceedences (HAF 114, 117 & 120) with methane ranging 0 - 34 % versus 1 % and / or carbon dioxide ranging 1 - 23 % versus 1.5 %. Subject to actions arising from NRW gas audit 20 & 21 August (reference PP3139GB/0249675).

c). CCS3 Suspended - Emissions to land and groundwater C3.2.3, S4.4

Groundwater borehole HA 12B(B) chloride levels July - September (HAF 115, 118 & 119) at 1300, 1400 and 1300 versus 450 mg/l trigger level. Borehole + 300 m away on the slip road of A483 has historically high chloride levels (with ammonia at < 0.44 vs 2 mg/l limit). Cory has drilled an exploratory replacement borehole on site in November of similar depth, strata and groundwater exposure and it will be subject to comparative monitoring and the pending Hydrological Risk Assessment (HRA) and any subsequent permit variation.

d). CCS4 Emissions to surface water C3.1.2, S4.3

Surface water discharge marginal exceedence at SW2 (HAF 116) in July of Total Organic Carbon 5.1 versus 4.8 mg/l limit.
