Compliance Q1 (January - March) 2016 - Monitoring Data Review

a). CCS3 - Leachate exceedances (reference HAF 130, 132 AND 134).

Cell 1 - 13.5, 13.4 and 16.3 m versus 2 m limit. Problems with foam and pump failures.

Cell 2 - 4.6, 3.3, 2.5 m versus 2 m limit. Level dropping steadily and expect to come into compliance.

Cell 3 compliant.

Leachate removed 2829, 2956 and 3033 m3.

b). CCS 3 - Various perimeter gas well exceedances (reference HAF 128, 133 and 135).

Methane ranging 0 - 45 % versus 1 % limit and / or carbon dioxide levels ranging 1 - 29 % versus 1.5 % limit (not under positive pressure). 18 new inboard wells drilled in Q1 2016 as part of improved infrastructure to improve gas extraction and reduce migration. Subject to annual NRW gas audit.

c). CCS4 Emissions to surface water (reference HAF 131).

SW2 Surface water discharge marginal exceedance of alkalinity of 340 versus 323 mg/l limit.
