Wednesday 11 Jan 17 16:40 A member of the public travelled down New Hall Road (Johnstown) and reported an excessive amount of rubbish and bin bags on the ground and in the trees. The caller claimed the waste was coming from Hafod landfill site. Thursday 12 Jan 17 08:30 NRW confirmed a large amount of litter in the area from the site.

Thursday 12 Jan 17 Hafod personnel were out picking litter all day. Hafod confirmed that the site starts closing to light loads as soon as the wind gets strong and yesterday called all customers at 10:00am to inform them that they were closing to light loads. They rang them again at 12:00 to say that they would be shutting the site and took the last domestic load at 13:30. One of the loads is considered to have had some plastic and paper in it, which is thought to be largely the material in the trees.
