4. Details of our assessment

Stenor CAR Form.

On 09 May 2022 a site inspection was carried out by Linda Warrick and Sally Wakeford at Stenor Limited in Fforestfach. We were not accompanied on site, due to there being one weighbridge operator available at the time, and was required to stay in the office.

Officers were on site due to a soils investigation currently being undertaken across Wales, and so an inspection was also carried out at the same time.

The weather was dry and clear.

The site comprises of bunds along the sides and rear, these were in place and no run off of water was obvious from the site.

The dust management systems were operational and effective, no escape of dust/debris onto the roadway was visible.

It was noted that the stockpiles to the rear on the left hand side of the site were close to the top of the bund. Concerns were raised on site with Carlie and on the phone with Steve Norman regarding stability of the slopes, and a reminder to check for cracking or evidence of slipping to ensure no waste leaves site and enters the adjoining watercourse.

With regards to the stockpile to the left at the rear of the site, please confirm when this waste came to site, and when it will be removed. In the past it has been confirmed that some of this material originated from site, however this stockpile has grown since this information was provided.
