4. Details of our assessment

Tony Bruten (TB) attended at the unit at 09.45 on Monday 20th June 2022. He met with David Morgan (owner) and site manager Robert Bicknell. The site is currently below maximum capacity for permitted birds.

A site walk over was completed checking drainage and emissions. All concrete on the unit was in excellent condition. No issues were identified.

No entry was made to the sheds so that all biosecurity issues were kept to a minimum.

Records were examined in particular following returns from BAT requirements completed in 2021.

All records were in order.

A discussion was had regarding the current 50/50 split of organic manure produced on the unit. Currently 50% is kept and used on site but this will be changing as it is proposed to use all the organic manure produced in the unit on their home farm.

TB made them aware of the **The Water Resources(Control of Agricultural Pollution)(Wales) Regulations 2021** and the requirements for storage, spreading and record keeping that is currently in being with new parts of the legislation coming into effect on 1st January 2023 and 24th August 2024. This new legislation will have sections that they will need to comply with.

A copy of these Regulations are attached below.

There were no Non Compliances identified during the visit and so no action required.
