CCS3 Various perimeter gas well emission exceedences for December 2013 with respect to methane ranging 0 - 48% versus 1% and / or carbon dioxide ranging 1 - 32% versus 1.5%. Score suspended following requirements of gas emissions audit PP3139GB/0197525.

CCS3 Groundwater monitoring borehole HA 12B(B) chloride 10 December 2013, 920 versus 450 mg/l. Borehole 300+ m from the site on the slip road of the A483 and has historically high chloride (attributed to gritting). Ammonia in compliance at 0.42% versus 2 mg/l.

CCS4 Surface water exceedence 10 December 2013 with respect to ammonia at 1.8 versus 1.6 mg/l.
