**4. Details of our assessment**

This Compliance Assessment Report (CAR) has been raised to review the final Q1 monitoring returns for water received via email on 21/06/22.

The first iteration of the Q1 monitoring returns for emissions to water were received on 27/04/22. These returns contained comments in relation to the quarterly reporting requirement as per Permit Condition 4.2.3, Schedule 4(b), Table S4.1 for Pentachlorophenol (PCP) and its compounds and adsorbable organically bound halogens (AOx). The comments stated that the operator was waiting for an external lab report that was due on the 04/05/22. No further update or finalised submission was received until prompted by the Natural Resources Wales (NRW) regulating officer on 21/06/22. Once prompted the returns were supplied immediately.

The monitoring took place as per Permit Condition 3.3.1, Schedule 3(b), Table S3.2.

No issues were identified on the finalised returns for Q1 monitoring.
