4. Details of our assessment

Joint site inspection undertaken by Michael Edwards of Natural Resources Wales and members of the Mid and West Wales Fire Rescue Service (FRS) accompanied by site manager Andy Evans.

The purpose of the visit was to assess the progress of the Regulation 36 enforcement notice that was served following the issues identified during the visit undertaken 26 May 2022 and for the FRS to undertake an assessment of the site and the Fire Prevention and Mitigation Plan (FPMP).

Progress has been made on all issues that were highlighted in Compliance Assessment Report CAR_NRW0039969. With a noticeable reduction in waste stored on site and granules available to collect oil spills.

As discussed on site, officers will attend the site following the deadline of the notice to determine whether the site is compliant with the conditions.
