Tony Bruten (TB) inspected the site on Tuesday 21st June 2022. On attending met with Laurence Raasch who runs the site.

General walk around site discussed clean and dirty water drainage, there were no non compliance issues. all dirty water is removed from site by Colin Phillips who also removes all solid Poultry manure.

Some maintenance going on at site, new concrete areas and a new entrance to the unit being constructed nearer the road to ensure that there is no unauthorised access to the site.

Discussed relevant paper work which was all in order and no non compliances.

Viewed cameras monitoring the birds in the sheds. During this current year of inspections TB not accessing sheds in order to minimise any biosecurity.

No issues no further action required.
