Emission point A12 - annual emissions monitoring completed 2nd March, all emissions compliant.

Emission points W1, W2 & W3 - all parameters within permitted limits.

I note that residual chlorine dioxide at emission point W2 was elevated at 2mg/l, significantly higher than recorded for the previous quarters. Please review the residual chlorine dioxide data for Q4, establish the possible cause and provide NRW with your findings.
