3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards of Natural Resources Wales accompanied on site by Mark Wiberg of M&R Commercials Limited.

General Management

During the inspection a copy of the EMS and permit were requested, and both were made available to the officer as required under **condition 1.1.3**.

A request was also made to review the certificate for continued competence of an approved competence scheme as required under **condition 1.1.4** however a certificate was unable to be provided.

Action – please forward a certificate of continued competency.

Storage of waste

Under the conditions of the permit, the site is limited to the acceptance and storage of End-of-Life Vehicles (ELV) waste only, as described in **Table 2.2**, with a maximum annual throughput of 5000 tonnes. These wastes must be stored on impermeable surface areas with sealed drainage.

During the inspection it was noted that some wastes were stored on hardstanding in several locations within the permitted area.

This has been scored as a **Category 3 breach** of permit **condition 2.3.1**.

Action – Ensure that all wastes are stored on areas of impermeable pavement with sealed drainage system as required under Table 2.3.

Site Operations

All activities under the permit were carried out within the highlighted permit boundary. A review of the technical requirements for ELV depollution was not undertaken during this inspection.

Waste Returns

Under condition 4.2.2 the site is required to submit annual waste returns within one month of the end of each year.

A review of the records held by NRW show that no waste returns have been submitted since 2015. This has been scored as a **Category 4 breach** of permit **condition 4.2.2**.

Action – The site must submit all missing waste returns as required under the conditions of the permit.
