### 4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised by the regulating Natural Resources Wales (NRW) officer to review the submitted abstraction returns. Essity holds two abstraction licences one for Oakenholt Reservoir Abstraction (24/67/10/0079) and one for Pandy Abstraction (24/67/10/0080). Aside from the above abstraction licences and installation permit (BJ9681IX), Essity holds a further Environmental Permitting Regulations

permit for the operation of the Scour valve discharge from Oakenholt Mill Reservoir (BB3696ZC). This CAR relates to Pandy Abstraction (24/67/10/0080) only.

NRW received abstraction returns by email on 06/04/22, this included historic returns as discussed with the operator. The Pandy Abstraction is not in use therefore as discussed a yearly nil return submitted in conjunction with the Oakenholt Reservoir Abstraction returns will suffice. Going forward if the Pandy Abstraction is utilised then abstraction returns will be submitted by email annually and the data will be presented as weekly totals. This will be the submission route for abstraction returns until NRW implements another system for abstractors to utilise.

No issues were identified in the submitted abstraction returns.
