### 4. Details of our assessment

A routine effluent sample collected from Tanygroes Sewage Treatment Works (STW) on 13 June 2022 was found to contain 58.5mg/l suspended solids. As condition 4(d)(ii) of Tanygroes' permit states that the discharge shall contain no more than 30mg/l suspended solids, this result represents a permit breach and has been scored accordingly.

In response to the above breach, Natural Resources Wales (NRW) ask Dŵr Cymru Welsh Water to investigate the cause of the breach and take measures to prevent a recurrence by 03 August 2022.

## Important information
