This Compliance Assessment Report follows a review of routine monitoring data for the period 1st January - 31st March 2013 and also the annual environmental monitoring review for 2012.

### 1. Leachate Heads

100% compliant throughout the period

### 2. Groundwater and Surface Water Quality Monitoring

No issues noted - no breach of permitted trigger levels or other issues of concern noted.

### 3. Perimeter Gas Monitoring

Monitoring in accordance with the permit. During the period there were a number of marginal CO2 trigger limit breaches as detailed below. Part A and B notifications received as required.

Trigger level exceedances are in breach of permit condition 3.1.2. The trigger breaches are marginal and have been consolidated with a single CCS score of 4 awarded. No further action beyond continued monitoring required. FCC are due to apply for a permit variation to remove CO2 trigger limits in accordance with the agreed Industry Code of Practice.

The dates / locations of CO2 breaches are;

29th January 2013 G1, G3, G4, G8 and G12 plus T8, T9 and T10

12th February 2013 G1, G3, G4, G10, G12 and G16 plus T8, T9, T10, T11 and T13

1st March 2013 G1, G3, G4, G12 and G16 plus T8, T9, T10, T11 and T13 .

### 4. Gas Engine & Flare Emissions Monitoring

The 2 gas engines and single enclosed flare were monitored October 2012 in accordance with permit requirements. Emissions were within permitted limits.

### 5. Annual Monitoring Review 2012

Thank you for providing the above report which I have reviewed with interest.

I note the FID/Flux box survey identified some significant LFG emissions from permanently capped areas but the report contains no interpretation as to the cause / source or what action has been taken since. I have now sent the report for further interpretation and will provide further comment in due course. In the interim please provide me with your interpretation of the data / measures you have taken to reduce the emission rate - please do so by 14th June 2013.
