This Compliance Assessment Report follows a review of routine monitoring data for the period 1st January 2015 - 31st March 2015.

1. Leachate Heads

Leachate heads were monitored monthly and compliant throughout the period (<1m).

2. Groundwater Quality Monitoring

Monthly and quarterly monitoring suites completed. During the monitoring period there was one trigger level exceedance on 21/01/15 for monitoring well BH7. Ammoniacal nitrogen was measured at 4.9mg/l (limit 1.3mg/l). FCC report that the well is located on a verge close the the site haul road / wheel wash and suggest that there was potential carry over of contamination by vehicles leaving the landfill. The well was re-sampled in February 2015 and ammoniacal nitrogen was below trigger level at 0.4mg/l.

The exceedances attracts a CCS3 (potential for minor environmental impact). Permit condition 3.2.3.

Please ensure measures are taken to minimise the carry over of organic material from the landfill and onto non-landfilled areas.

3. Perimeter Gas Monitoring

During monthly monitoring in January, February and March 2015, the methane trigger of 1% was exceeded at monitoring wells G11 and T10.

G11 - January 2.1%, February 1.9%, March 2.2%

T10 - February 4.8%, March 3.9%

T10 is close to T11 which is known to include methane from non landfill sources and possibly related although unproven. The methane detected in G11 may be of landfill origin.

Part A and B notifications received as required. Trigger level exceedances are in breach of permit condition 3.1.2. The trigger breaches are marginal and have been consolidated with a single CCS score of 4 awarded. Since 4th April 2015, no further breaches of methane trigger limit have occurred.

4. Surface Water Quality Monitoring

No discharges from the surface water lagoons / grass plots reported during this period.

Samples collected from the River Dee upstream and downstream of the landfill are indicative of a high quality watercourse. No issues noted.
