This Compliance Assessment Report follows a review of routine monitoring data for the period 1st January – 30th June 2016 and the 2015 annual report. All reports received on time – thank you.

1. Routine Monitoring Data

Leachate Heads

Leachate heads were monitored monthly and compliant throughout the period (<1m). Leachate quality monitoring completed as required.

Groundwater Quality Monitoring

Monitoring completed as required by the permit – no trigger levels exceeded, no issues noted.

Perimeter Gas Monitoring

No trigger levels exceeded during this period.

Surface Water Quality Monitoring

Monitoring completed as required by the permit. No discharges from the grass plots reported during this period. Samples collected from the River Dee upstream and downstream of the landfill do not indicate any impact from landfilling operations. No issues noted.

2. 2015 Annual Report

I have reviewed the information included in the 2015 annual monitoring review and do not note any issues of concern. Amongst other information the following key reports were provided;

- a) Landfill Gas Engine & Flare emissions monitoring 2015 – all emissions within permitted limits.
- b) Landfill Gas trace gas analysis 2015
- c) Flux box survey 2015 – no issues noted.
