This Compliance Assessment Report follows a review of routine monitoring data for the period 1st October 2014 - 31st December 2014 and annual reporting in accordance with permit condition 4.2.1 (b - j). An annual review of data collected during 2014 (4.2.1a), trace gas and and CHP / flare emissions is due for submission by end March 2015.

1. Leachate Heads

Leachate heads were compliant throughout the period with the exception of LM4B recorded at 1.62m on 30/12/14. A part A notification was received as required reporting that silt and debris at the base of the well was inhibiting pumping. The pump was raised above the permitted head to enable some pumping to continue.

A Part B notification was received January 2015 reporting that the well and other wells were de-silted on 12/01/15. The pump was returned to the well base and leachate pumped down to <1m.

The exceedance of leachate head limit is a breach of permit condition 2.9.1 and attracts a CCS score of 3.

Please ensure the depth of silt within wells is carefully monitored and remedial action taken before pumps are adversely affected.

2. Groundwater Quality Monitoring

There were no breaches of trigger limits during the monitoring period.

3. Perimeter Gas Monitoring

During October there were CO₂ trigger limit breaches in wells G1, G3, G4, G8, G12, T1, T3, T3, T8, T10 & T11. There were no methane trigger breaches associated with these wells during this period indicating that the gas is unlikely to be caused by LFG migration although it cannot be ruled out entirely.

The permit was varied 03/11/14 to replace CO₂ triggers with action limits. During the next site inspection the actions taken by FCC for control level exceedance will be assessed.

Part A and B notifications received as required. Trigger level exceedances are in breach of permit condition 3.1.2. The trigger breaches are marginal and have been consolidated with a single CCS score of 4.

4. Surface Water Quality Monitoring

No discharges from the surface water lagoons / grass pots was reported to have occurred during this period.

Samples collected from the River Dee upstream and downstream of the landfill are indicative of a high quality watercourse. No issues noted.
