This Compliance Assessment Report follows a review of routine monitoring data for the period 1st April 2015 - 30th June 2015.

1. Leachate Heads

Leachate heads were monitored monthly and compliant throughout the period (<1m) with the exception of 30/04/15 when heads for LC4b and LM4b exceeded the limit at 1.39m and 1.52m respectively. Part A & B notifications received.

It was reported that cable was stolen from the leachate pumping system preventing the normal operation of the system. Measures were taken to resume pumping (installation of a dedicated diesel generator), and leachate heads have remained compliant since. The leachate head exceedance is a breach of permit condition 2.9.1. As the head limit exceedance was temporary in nature the potential environmental impact is considered to be negligible and therefore a CCS score of 4 is applied.

Please ensure all reasonable measures are in place to deter unauthorised access to the site and to protect environmentally critical equipment.

2. Groundwater Quality Monitoring

Monthly and quarterly and annual (hazardous substances) monitoring suites completed. During the monitoring period there were 3 trigger level exceedances (Part A and B notifications received);

Well T9, ammoniacal nitrogen 1.9mg/l (limit 1.6mg/l), chloride below trigger.

Well T3, mecoprop 1.9ug/l (limit 0.04 ug/l), no values above 0.04ug/l in recent data and other parameters are low. A sample retest confirmed a result at the limit.

Well T10, nickel 0.097 ug/l (limit 0.03 ug/l), this well has experienced occasional limit breaches. Result not accompanied by a rise in ammonia or chloride.

FCC to continue monitoring as per permit requirements and review for signs of increasing trends (deterioration of groundwater quality). HRA assessment is currently underway.

The exceedances detailed above attract a CCS3 (potential for minor environmental impact). Permit condition 3.2.3.

3. Perimeter Gas Monitoring

During monthly monitoring in April 2015, the methane trigger of 1% was exceeded at monitoring wells G11 (2.2%) and T10 (2.7%). As noted in the previous monitoring review, T10 is close to T11 which is thought to include methane from non landfill sources, possibly related although unproven. The methane detected in G11 may be of landfill origin.

Part A and B notifications received as required. Trigger level exceedances are in breach of permit condition 3.1.2. The trigger breaches are marginal and have been consolidated with a single CCS score of 4 awarded. Since 4th April 2015, no further breaches of methane trigger limit have occurred.

4. Surface Water Quality Monitoring

No discharges from the surface water lagoons / grass plots reported during this period. Samples collected from the River Dee upstream and downstream of the landfill are indicative of a high quality watercourse. No issues noted.
